### Overview of South Church Finances

South Church finances consist of Operating Funds and Trust Funds. The Operating Funds are managed by the Church Treasurer and The Finance Ministry with guidance from other Ministry Teams. The Trust Funds' investment is managed by the Trustees of the Trust Funds. They include proceeds from plot sales invested to provide for the perpetual maintenance of the Cemetery and proceeds from bequests which are invested to support a wide range of church programs in accordance with any restrictions placed on those grants.

A summary of the Operating Funds is included on the "Financial Position Summary" page. Most church income is from Annual Giving which is allocated among the General, Building Reserve, Missions Fund and Reserve Fund. A summary of this Annual Giving and details of the 2024 General Fund activity and the proposed 2025 budget are on the two pages which follow the financial position summary. The General Fund provides the money for budgeted program activities and the "day-by-day" operating expenses of the church. Following that are details of the Building Reserve Fund.

Trust Funds balances and activity are reported as part of the "Report of the Trustees of the Trust Funds". The church Giving Summary follows the "Report of the Missions Team".

### Report of the Trustees of the Trust Funds – Year Ending 2024

The Trustees of the Trust Funds are three members appointed for a single six-year term and are responsible for managing the endowment of South Church. There are two separate funds: the Cemetery Fund and the Trust Fund, each with a distinct and separate purpose. The following breakdown of year end investment balances are used to calculate the following year's disbursements based upon a new calculation approved by the TOTFs as further detailed below.

#### **Cemetery Fund:**

The purpose of this fund is to provide predictable income to cover annual maintenance costs of the cemetery and cannot be used to finance any general church operations. It consists of contributions by those who wish to see the cemetery well-maintained and includes money received for purchase and perpetual care of cemetery lots. It is to be used exclusively for upkeep of the cemetery including gravestone repair, landscaping, and shrub/tree maintenance.

Note Adjustment to 2025 Distributions for the Columbarium Project

#### Trust Fund:

The purpose this fund since the late 1800's has been to provide a predictable source of income in perpetuity in accordance with individual bequests. It is managed as one pool for investment purposes and to mitigate risk and distributed to specific Church accounts according to the wishes of the donor and for general purposes if no direction was provided.

#### **Overview of 2024 Performance:**

2024 was another strong year, with the accounts averaging a return of 14.02%, performing in line with their benchmark. In terms of performance attribution, outperformance was primarily driven by the allocation to an actively managed bond fund, which outperformed the fixed-income benchmark. Additionally, a slightly higher allocation to U.S. equities compared to the strategic allocation/benchmark, combined with an underweight exposure to international equities relative to the benchmark, also contributed positively.

On the other hand, underperformance stemmed from the allocation to small-cap and value stocks, which are not included as separate asset classes in the benchmark. These segments lagged the broader market, as much of the year's returns were concentrated in the large-cap growth sector.

Overall, the committee is pleased with the accounts' performance and remains confident in the current allocation as outlined in the benchmarking matrix below.

#### Motion by Trustees to Fund the Columbarium Project:

At the September TOTF meeting, the Trustees reviewed a proposal from the Church's leadership to consider funding part of the budget for the "Columbarium Project" to be built on the South Church property. The need for the Columbarium results from the growing demand for accessible plot locations and only limited sites remaining in the cemetery. The design has the support of both Church Council and leadership. The total cost of the project is estimated to be ~\$500,000 and construction is expected to begin late spring/early summer once the contractor is selected. The Columbarium will house a total of 400 "niches", which are the space designed to hold cremation urns, and each niche can hold several urns subject to final design. The proceeds from all sales will inure to the Cemetery Fund to replenish any contribution made by the TOTFs. The sources of funding include estimated presales of \$100,000 plus \$85,000 from excess contributions from the Cemetery Fund over recent years. From these estimates, the Trustees have been asked to fund the remaining cost of the Project, which is estimated at ~\$315,000. There is the potential for cost overruns and the presales could potentially take longer than expected. Hence, the Cemetery Fund may be called upon to exceed the current estimated funding amount. This project uniquely serves the purpose of the Cemetery Fund, which has grown to \$1,964,304 as of year ending 2024, and has the historic challenge of spending its distributions for purposes required under its charter. With these drivers in mind, the Trustees of the Trust Fund approved the target commitment amount plus additional funding if required. Given the fact that the Church's funding needs for the cemetery are approximately \$35,000 per annum and the distribution for 2025 is \$76,224, the Trustees also moved that until the \$315,000 principal amount contributed to the project is recovered, the distributions will be limited to \$40,000 per year beginning in 2025. Such amount will be adjusted for inflation or as needs at the cemetery arise.

#### **Outlook for 2025**

While many challenges will arise in the New Year, we remain confident that South Church's endowment funds will weather any storms that arise plus benefit from improvements in the financial markets over the long haul.

### Memorial Gifts Team

Memorial Gifts meets a few times a year via email. We administer donations given to the church in memory of those who have passed and in honor of those who are still with us.

We received a major gift from the Phil and Virginia Dennent family, which went toward the Library and Music Funds. The Library Committee purchased furniture.

The Music Team purchased bells and chimes to fill the breadth to five octaves.

A gift in honor of Doug Halsted went toward the purchase of handbell cases.

We accepted gifts in memory of our past loved ones with the designation of Building Maintenance which will go toward the purchase of sound dampening baffles in Fellowship Hall in 2025.

The Memorial Gifts Committee continues to acknowledge gifts; to contact those people who memorialize loved ones with the lighting of the steeple each month; to review the committee's financial reports; to consider requests of church committees and boards for use of funds; and to maintain two Remembrance books: one in a case in the Narthex, and a copy in the sitting area near the church offices.

We encourage committees and boards within the church to contact Memorial Gifts about needs that are not included in a regular budget. Some funds have a specific purpose designated by the family; other funds are available for the purchase of any tangible gifts that will benefit the church and are consistent with our church's mission.

### Report of the Community Service Ministry

### **Missions Team**

South Church continues to be extremely generous in their giving of time, treasure and talents. The mission team worked hard all year to provide South Church with opportunities to share their gifts. The team works hard to follow the team charter to "lead the congregation in creating connection with our mission partners through education, financial support, hands-on service and authentic equity-based relationship building; to live into Jesus' example of justice, equity and inclusion through our actions and resources." The mission team continues to have a full slate of members and we enjoy support of our Associate Pastor, Genna Hosterman and the Community Service team leadership. We met monthly via Zoom, allowing flexibility for members to participate remotely

The Mission Team continued to distribute our budgeted funds (\$65,500) to our core mission partners; International partners include Honduras Hope, La Gonave (Haiti) and Only a Child (Guatemala). Our local partners include Neighbors in Need, Lazarus House, Bread and Roses, A Better Chance of Andover, Habitat for Humanity, South Church Giving Garden and Communities Together. Thirty percent of our budget goes towards supporting the United Church of Christ.

Our monthly mission partner program continues to offer our congregation different organizations to support. This year we gifted approximately \$41,452 to the following organizations: RCP-USP, World Central Kitchen – Middle East, Prison Book Program, Partner's in Health Sierra Leon Health Care, Bee Conservancy, NAGLY, Giving Garden, Andover Farmer's Market, Lawrence Boys & Girls Club, UCC Hurricane relief, and Eliot Day Center. Collections to support our youth missions raised \$860. We used \$3,900 of additional funds for emergency grants to Partners in Health Haiti and World Central Kitchen – Hurricane relief.

Hundreds of books were collected and sent to Prison Book Program and Memorial Hall Library in conjunction with the monthly mission partner collection. Diapers were collected for the annual Undies Sunday drive for Communities together. The congregation donated 80 new children's books to The Boys and Girls club.

Our team did a thorough review of all Core Partner financials to ensure that all partners were continuing to serve their mission and continue to align with the mission of South Church. After the review we felt it was important to remove a couple of partners and realign the annual grants to existing partners. We also added the Andover Farmer's Market SNAP/GAP program as a core partner. We will continue to review partners on an annual basis to ensure we continue to make the best decisions with our mission dollars.

The Mission Team is proud to provide opportunities to embody God's love and compassion and to actively nurture connections within and beyond our walls to bring meaning and joy in spiritual growth, fellowship, and service.
